If at any stage after accepting this offer, you decide that you wish to change your program of study or intake, the change(s) will require approval from the University Registrar. If such a change requires you to complete additional subjects or lengthen the duration of your program, you will be responsible for meeting additional tuition or other costs. The Leadership Scholarship cannot be exchanged for cash or applied to the Bond University Medical Program and postgraduate programs.
