Canterbury College's Expectations of Homestay Parents

- International students are expected to conduct themselves responsibly when at school, in homestay or during other activities. Students are expected to behave in a manner which supports the College's expectations of not smoking, not consuming alcohol or illegal substances. Students are expected to conduct themselves in a safe and responsible manner at all times. Concerns about student behaviour should be directed to either or both of the Homestay Coordinator and Head of Secondary School:

- 1. Family members in the homestay environment are expected to conduct themselves in a responsible manner so as to provide a safe, caring and positive environment.
- 2. All adults over the age of 18 are required to hold a current Working With Children Blue Card.
- 3. Homestay families are expected to attend at least one of the College's annual homestay information sessions per year
- 4. Subject to the specific regulations, which can be provided by the Homestay Coordinator, visitors staying in your home for a period of serval days are required to hold a current Working with Children Blue Card
- 5. The Canterbury College Homestay Coordinator should be advised of any changes in your details, such as phone, address, pets, other international students living in your home, etc.
- 6. Study Tour students must be driven to and from school every day. Study Tour students may only catch a school bus if they are staying in the home of a Canterbury family and can be escorted by a Canterbury student to and from the designated drop off and pick up area. Homestay families must discuss this with the Homestay Coordinator prior to the study tour.
- 7. Students come to practise their English Language Skills please only speak English in the home.
- 8. All students, including international and study tour students, should not be dropped off any earlier than 8:00am at the designated area. Students should not be collected any later than 3:30pm from the designated area, unless they are involved in a school related activity such as sport.
- 9. Homestay families should provide three meals a day, plus drinks and snacks.
- 10. It is expected that homestay families include visiting students in all family activities such as; outings, family meals etc.
- 11. Students should not eat at a separate table to the homestay family.



- 12. Homestay families should provide a laundry service (washing and ironing) at least twice a week since students will come with a limited amount of clothing.
- 13. Hot and cold water and electricity must be provided 24 hours, seven days per week.

Disclosure of Personal Information.

- 14. Canterbury College (the School) collects personal information, including sensitive information about current students, past students, enrolled students, prospective students, their parents/guardians, their homestay parents and others before, during and after the course of the student's enrolment at Canterbury College. As a homestay parent, the School will also collect and store the information you have provided to us.
- 15. The primary purpose of collecting information is to allow the College to exercise its responsibilities, The College collects, uses, holds and discloses personal information in accordance with the Privacy Act 1988 (Cth) and the Australian Privacy Principles (APPs).
- 16. College files contain many and varied pieces of information in relation to the enrolled student. Such files are considered confidential.
- 17. If you object to Canterbury College's obligations under the Australian Privacy Principles, please put your concerns in writing and forward these to Canterbury College Administration.

Co-Curricular Activities
